Dear Secretary

After announcement of NEP, 2020 in July, 2020, various stakeholders including States and UTs have taken initiatives for its implementation. NEP, 2020 recognizes that the teachers and faculty are at the heart of the learning process and that the in the success of higher education institutions most important factor is quality and engagement of its faculty. Accordingly, for smooth implementation of NEP-2020, about 15 lakh teachers of universities and colleges need to be oriented on various recommendations of the policy.

2. In this regard IGNOU has developed a 36-hour (6 days) Professional Development Programme (NEP-PDP), which is equivalent to UGC-HRDC short-term PDP, and can be completed in a maximum of 9 days.

3. For the NEP-PDP, teachers can register at the SAMARTH platform organised by various IGNOU Regional Centres (in respective states), and the programme delivery shall take place on the SWAYAM platform. It comprises of the following components:

- E-Content: 14 units (in English and Hindi) on important themes of NEP-2020.
- E-Tutorial: 30 high quality video lessons by eminent scholars.
- Discussion Forum: at the Swayam platform.
- Live Conferencing: through Swayam Prabha TV Channel 20, with interactive chat facility.
- Assessment: Formative Online Test (30%) and Summative Online Test (70%) on the Swayam platform.
- Certification: Automatic digital certification on successful completion with 50% score.
- The videos shall also be available on YouTube and be telecast on Gyan Darshan TV, and all resources shall be available on E-Gyankosh.

4. The nation-wide registration for the NEP-PDP has started on August 15, 2022. More than 30,000 teachers are registered. The first pilot batch of around 6,000 teachers has started. A Flyer and Programme Brochure are enclosed for kind perusal.

5. I would therefore, request you to urge HEIs in your State / UT to encourage their teachers to register in this one week online programme. The programme shall be conducted through various batches, and a teacher can register for any suitable batch at the Samarth platform meant for this purpose (<https://ignou-nep-pdp.samarth.ac.in>).

About NEP-PDP

This Professional Development Programme (NEP-PDP) on implementation of National Education Policy-2020 is offered by IGNOU, and approved by the University Grants Commission (UGC) as equivalent to UGC-HRDC Programmes.

The new *National Education Policy - 2020 (NEP-2020)* was notified by the Government of India in July 2020, 34 years after the last NEP was notified in 1986. The NEP-2020 provides for a comprehensive, sustainable and reformatory roadmap for a paradigm shift in the entire education system in the country, and is culturally grounded, is geared toward quality transformation, and is internationally competitive. In so far as higher education is concerned, besides proposing for foundational principles for educational change in relation to Indian traditional knowledge, culture and values, the NEP-2020 proposes reforms in all areas of higher education, including its structure, curriculum and pedagogy, teaching-learning strategies, learning resources and technology-enabled learning, vocational education and skilling and employability, 21st century learning and social and life skills, optimal learning environment and learner support, formative and summative assessment, internationalization, research and scholarship, governance and leadership, and regulation and accreditation.

There is now a need that all the college and university teachers in the country get exposed to the nuances and implementation strategies of the National Education Policy- 2020 (NEP-2020) so that their implementation in institutional contexts becomes smooth, effective, and sustainable.

This NEP-PDP is a 36-hour training programme, recognised by UGC as equivalent to 6-day short-term professional development programme of UGC-HRDC. One can successfully complete the programme within 6-9 days duration; and the certification on successful completion of the programme shall also be equally useful for purposes of API, CAS and any other career advancement requirements specified by UGC.

Who Can Participate

Any teacher of any Higher Education Institute in India can register and participate in the Professional Development Programme on National Education Policy-2020. The teacher has to register at the Samarth-NEP Portal (<https://ignou-nep-pdp.samarth.ac.in/>) by uploading institution I-Card or letter from the head of the institution.

How to Take Part in the Programme

Any teacher of any Higher Education Institute in India can register and participate in the Professional Development Programme on National Education Policy-2020.

1. Visit the Website of NEP-PDP <https://ignou-nep-pdp.samarth.ac.in/>
2. Carefully read the instructions before Registration.
3. Keep soft copy of your institution Identify Card or copy of Recommendation Letter by the Head of your Institution as proof of your being a teacher in that institution. Also keep soft copies of your passport photograph and signature.
4. Click on the Registration Link given on the Home Page of the NEP-PDP Website.
5. Fill up the required information and upload the required documents including photograph and signature as mentioned at point number 03 above.
6. Select the Training Slot of Dates for NEP-PDP that you intend to attend.
7. Preview your Form and check the selected slot for your training, and submit the Registration Form.
8. You will receive the information about the submission of your application, and subsequently the confirmation of registration and the slot for the programme.
9. The programme will be offered through the SWAYAM platform.

- ✓ All these shall be operated at the SWAYAM portal, and implemented by IGNOU-HQ (NEP-PDP Implementation Committee and WG-3 and Control & Monitoring Unit at STRIDE). The registration on Samarth portal shall be undertaken by the Regional Centres of IGNOU.
- ✓ IGNOU Facebook shall also be connecting to all of these.
- ✓ Each Programme slot/batch shall be monitored and evaluated by the WG-5 of the Implementation Committee.

What it Contains (SWAYAM)



E-CONTENT

In this programme you will be provided learning units and videos. You can access the e-content online as well as download the units and videos on your device.



LIVE CONFERENCING

After going through the e-content, you will join a live conferencing presentation and interaction session.



DISCUSSION FORUM

After completing the live conferencing session, you will join the Discussion Forum. You need to give the online MCQ test having 30% weightage which will be based on the topics covered in the modules and videos, and the discussion forum.



ASSESSMENT & CERTIFICATION

At the end of the programme, you need to give a Final Online MCQ test with 70% weightage. If you get 50% marks out of 100 marks, you will get the Digital Certificate of completion. The grade and scores shall be mentioned in your certificate.
