It is hereby notified for information of all concerned that, as per the directives of Academic Council, the Board of Studies in Microbiology has prepared the norms under **Regulation No.2022 to take the ENTRANCE TEST for admission to M.Sc. Microbiology run at affiliated colleges** under the Faculty of Science. The Hon'ble Vice-Chancellor has accepted the said Regulation, on behalf of the **Academic Council and Management Council Under Section-14[7] & 14[8] of the Maharashtra Universities Act, 1994 to implement from the Academic Year 2013-2014 and onwards.**

**Regulation-2022 :-**

**Each college running M.Sc. Microbiology should conduct Entrance Examination as follows :-**

1. Candidates with only B.Sc. Microbiology as One of the Optional Subject is eligible for entrance as well as admission to M.Sc. Microbiology.
2. The Entrance Examination should be of 100 Marks with cutoff of 40. The Pattern of Examination is of Multiple Choice Questions, no negative marking.
3. The Entrance Examination is based on syllabus of B.Sc. Microbiology.
4. Admission to said course of M.Sc. Microbiology is based on Merit list of entrance and all other required rules of admission.
5. The Fee for Entrance Examination is Rs.200 for Open Category and Rs.100 for all Reservation Category.
6. **Entrance Examination will be conducted by the College amongst from the registered students for the said course. The preparation of Question Paper and Valuation of Answer Sheet should be carried out by the Colleges at their Own Level.**

This is effective from the **Academic Year 2013-2014** and onwards.
