**Subject:-** Audit exercise as per the direction of Bombay High Court dt.  
07/02/2020 in Writ Petition no.792 of 2019

Sir,

With reference to the Writ Petition no.792 of 2019, the Hon. Bombay High Court had directed this office to conduct an audit exercise pertaining to the subject mentioned above. The Hon. High Court has directed that the team of officials appointed for the audit exercise is expected to give the petitioners a minimal opportunity to place their grievances so that all the records and documents in their possession would be made known and the version of the petitioners be considered.

The team of officials is also expected to give an opportunity to the competent official or authority in the concerned University and ascertain from him or it the manner in which the nomenclature of the posts as per the staffing pattern were changed and the subsequent pay scale revision on the basis of the change in nomenclature/ label.

Hence, this office requires that the University to submit the information about petitioners in the format as per Annexure I (enclosed). For each petition, the details of one authorized representative of non-teaching employees may be provided as per Annexure II (enclosed) so that he/she could be invited for the audit exercise and an opportunity could be extended to place the grievances of petitioners before the team of officials at a place and time which will be intimated at a future date.


As per the orders of the Hon'ble High Court, while naming the authorized representative of non-teaching employees in Annexure II, following conditions are required to be followed:

- i) If there is a Union of the non-teaching employees of the University and of which the petitioner is a member, the name of the office bearer or authorized representative must be mentioned in the Annexure II.
- ii) If the petitioner/ petitioners is/ are not a member of any Union of non-teaching employees, only then, the individual/ group of petitioners must authorize amongst themselves, a representative of theirs, who would represent them on the matter.
- iii) The authority letter of all the petitioners, writ petition wise, in the format mentioned in Annexure III must be submitted to this office in soft copy latest by 5<sup>th</sup> January 2021 on the mail id [agauMaharashtra1@cag.gov.in](mailto:agauMaharashtra1@cag.gov.in) . The authority letter, in original, will be collected by the team of officials in person, from the authorized representative of the petitioners during the visit to the University.
- iv) None of the Unions or the representatives of individual petitioners can engage the services of an advocate or legal practitioner while placing their grievances before the team of officials. The authorized representative of non-teaching employees would be invited by the team and he/she would be required to present the grievances of petitioners along with supporting documents.

This letter may please be circulated among the petitioners and an acknowledgement to that effect may be forwarded to this office for record.
