- 4) Quotation should be submitted in 2 different envelopes 1) Technical Bid 2) Financial Bid (You can use a large envelope to send both (Technical Bid & Financial Bid) envelopes together. Pl. mention clearly which envelope is for Technical Bid and which is for Financial Bid.

1) Technical Bid (Technical Specifications):-

Brief description of certification body should be sent along with following proofs.

- a) *Certification Body Should be Member of IAF and Proof should be attached which clearly mention that Certification Body is Member of IAF.*
- b) *Certification Body should have NABCB accreditation and a Proof should be attached which clearly mention that Certification Body should has NABCB accreditation.*
- c) *Certification Body should have local office and a Proof should be attached which clearly mention that Certification Body has local office at Aurangabad.*
- d) *Certification Body should have own qualified Auditors of Education Field and a Proof should be attached which clearly mention that Certification Body have own qualified Auditors of Education Field. (List of Auditors should be attached)*
- e) *Certification Body should have minimum 10 Clients from Education Field and a Proof should be attached which clearly mention that Certification Body have minimum 10 Clients from Education Field.*

All Above Mentioned Proofs should be enclosed in Sealed Envelope of Technical Bid
