Under DBT funded project “Constructive Utilization of Agro-waste” provided training on New Compact Biogas Technology, Vermiculture, Vermicomposting and Vermiwash techniques to rural people for support their economy.

In addition I have made significant contribution for the cause of preserving the native honey bee population as well as fostering and developing apiculture awareness campaigns in Marathwada rural and distant district. The goal of this admirable endeavor was to raise farmer’s living standard by using honey bees for natural pollination rather than making use of the expensive fertilizers to improve the yield. My perseverance and hard labour paid off, as evidenced by the quick increased in harvest quality and quantity. I have published 53 popular articles on beekeeping in newspapers in Marathi, and uploaded 10 various videos on YouTube to about the popularity and importance of the beekeeping. As reward of my outstanding and never ceasing efforts with priceless contribution, I have been felicitated by many research bodies and personalities, the most noteworthy being the auspicious hands of Nobel Laureate Shreeman Kailashji Satyarthi. Recently Maharashtra State Khadi & Village Industries Board, awarded me an Advisory Membership.
