

It should be re-consider for every FIVE YEARS at the time of publishing 'Five Years Perspective Plan' of the University.
2. The university shall have an additional fee of **₹. 15,000/-** (+ 18% GST Separate) towards the Academic and Administrative Audit (AAA) for a period of three years.
3. The university shall have an additional fee of **₹10,000/-** (+ 18% GST Separate) towards the No Objection Certificate (NOC) of AICTE. (Ord. 152 [B])
4. As per Ordinance 150(A) for Under Graduate courses, the aforementioned affiliation fee covers only Two divisions or One branch. Thereafter, an additional fee of ₹. 6,490/- (inclusive of 18% GST) shall be charged for **EACH** additional Division or Branch.
5. As per Ordinance 150(A) for Post Graduate courses, the aforementioned affiliation fee covers only One division or One branch. Thereafter, an additional fee of ₹. 6,490/- (inclusive of 18% GST) shall be charged for **EACH** additional Division or Branch.
6. **There will be an annual increase of 2% in the fees effective from the upcoming academic year 2027-28. This increment will be applicable at the beginning of each academic Year.**
