#### Evaluation process of IA marks may be as follows:

- ➤ The second component (C<sub>2</sub>) of assessment is for 20 marks, this shall be based on test, assignment, seminar, case study, field work, internship/industrial practicum /project work etc. This assessment and score process should be based on completion of the remaining 40% of syllabus of the courses of the semester.
- ➤ During the 15<sup>th</sup> week of the semester, a semester and examination shall be conducted by the University for each Course. This forms the third and final component of assessment (C<sub>3</sub>) and the maximum marks for the final component will be 60%.
