3.1 Master of Social Work (MSW)

- Sanctioned Seats MSW –I = **60 Seats** MSW-II = **60 Seats**
- Full time postgraduate degree course comprising of 4 semesters spreading over 2 calendar years.

3.1.1 Admission Procedure :

As per norms lay down by Dr. Babasaheb Ambedkar Marathwada University, any graduate from recognized University is considered eligible to apply for admission to MSW program being conducted in this department.

The admission process to MSW is completed by selecting candidates through CET examination and degree level marks obtained by the students in 50:50 proportion .

3.1.2 Performance Evaluation :

Performance of the students in all course components including classroom lectures, Social Work Practicum, Research Project, Study Tour, Rural Camp communication skill exercise ,field work presentation , learning support activities and internship (block placement) is mandatory. 75% attendance is essential in theory classes, field work practicum and individual and group conferences . There is **continuous evaluation** of the student. The student is evaluated by using decentralized way.

6. Assessment Methods and Examination

To be eligible to appear for MSW examination, the candidate must have fulfilled 75% classroom attendance in each core elective and service course and 90% attendance in social work practicum.

6.1 Assessment Methods

The evaluation of each of the components of MSW program i.e. theory course TC, Social Work Practicum SWP, Research Project RP is conducted internally and externally and performance in various practical based events, Summer Camp and Internship Block Placement is examined internally.

6.1.2 Theory Courses

Each 4 Credits Theory Course is for 100 Marks, divided into Internal Assessment of 40 Marks and External Semester End Examination of 60 Marks .

Each 2 Credits Theory Course is for 50 Marks, divided into Internal Assessment of 20 Marks and External Semester End Examination of 30 Marks .

For Paracticum , the Internal and External Assessment is 80:20 proportion .

6.1.2 A) Internal Assessment for Theory Courses – 40 Marks

For enriching students experienced based knowledge Approach has been accepted , weightage has been given to presentation skills through various means. Every course will be presented for internal assessment by using following ways—10 Marks for Each activity.

For **Sem-I-** Analysis of News in Different News Papers , Seminar , Power point Presentation

Sem-II- Functional Use of Computer , Real Making , Extempore Reflection

Sem-III- Conflict Resolution Skills, Focused Group Discussion, Collaboration Activities / Program Management

Sem-IV-Case Study, Communication Skills, Research Paper Writing

6.1.2 B) Term End Examination - 60 marks

Each Theory Course question paper shall consist of two sections.

Section A (10 Marks) consists objective type questions carrying 1 Marks for each question which covers entire syllabus. It is compulsory part of the paper.

Section B (50 marks) consisting five questions .

6.2 Social Work Practical (SWP) and Research Project (RP)

Orientation Visit , Concurrent Field Work, Summer Placement , Rural Camp, Study Tour , Block Placement, Individual and Group Conferences are the Heads of Assessment of Social Work Practicum.

Research Project is mandatory course in MSW. It develops ability to conduct research. It promote Social work shouldn't to investigate social issues. The Performance in Project Report is measured independently in Semester III and IV on the basis of steps involved in research

methodology. The Dissertation is submitted in IV Semester. Research Project is assessed in 4th semester.

6.3 Summer Placement :

For facilitation of Social Work intervention in agencies, students are placed for a week in handling issues of communities.

6.4 Internship (Block Placement)

Block Placement is mandatory component of training in social work. The assessment is done on the basis of performance of the student in Internship in various social work agencies for the period of 30 days.

6.5 Evaluation Reforms

- Time bound continuous evaluation of Social Work Practicum and of research project has been introduced.
- Criteria for evaluation of each activity has been clearly specified and inform to the students before commencement of the activity.
- Phase-wise evaluation of Research Project has been introduced.
- Field Work coordinators and in charge of Research Project Report committee effectively execute the evaluation reforms by designing the time schedule of the activity and by coordinating the functioning of all teachers in the academic areas.
